We, at Art Works Studio Ltd, respect your right to privacy and comply with our obligations under the General Data Protection Regulation. The purpose of this Data Protection Policy is to set out how we deal with personal data provided to Art Works Studio Ltd while visiting the Me and The Moon website - www.meandthemoon.ie and other individual Art Works Studio Ltd associated websites under Art Works Studio Ltd management, namely www.sheenakfortune.com and www.davidfortuneart.com.

Any links to other external websites are clearly identifiable as such, and Me and The Moon has no responsibility for the content or the privacy policies of other third party websites. While we take care of the safety of information on our websites on an ongoing basis, if you are not happy with this policy you should not use any of our websites.

OUR COMMITMENT

We are committed to the principles inherent in the GDPR and particularly to the concepts of privacy by design, the right to be forgotten, consent and a risk-based approach. In addition, we aim to ensure:

- transparency with regard to the use of data
- that any processing is lawful, fair, transparent and necessary for a specific purpose
- that data is accurate, kept up to date and removed when no longer necessary that data is kept safely and securely.

DATA COLLECTION AND MANAGEMENT

1. Types of data/information collected by Art Works Studio Ltd

We collect and further process two types of information:

"Personal Data"

This is data that identifies you or can be used to identify or contact you and may include your name, address, e-mail address, user IP addresses in circumstances where they have not been deleted, clipped or anonymised and telephone number. Such information is only collected from you if you voluntarily submit it to use and we use it to deliver our various services and information to you. Art Works Studio Ltd collects personal data in the following circumstances:

- i. When you sign up to an in person service; such as booking in a child to a 'Me and The Moon' workshop, camp or event. Individuals are asked to let us know basic information about their child, personal contact information of the parent/guardian and whether or not the child has any special needs or requirements we need to know about. The legal basis for such data protection is to facilitate the necessary performance of the contract of facilitating workshops to the child in a safe and structured manner.
- ii. When booking 'Me and The Moon' for a pop-up event such as festivals, corporate or private functions. Individuals are asked for their name, contact information and general information about the event in order to provide a tailored workshop experience and a smooth running of the event on the day.

- iii. When booking a design service with Sheena K Fortune / Me and The Moon. New clients are asked for their name, contact information and detailed information about the project in order to provide an optimum design experience.
- iv. In addition, we use cookies on our websites meandthemoon.ie, sheenakfortune.com and davidfortuneart.com to provide social media features.

"Non-Personal Data"

Non-Personal Data (NPD) is electronic data that does not contain any information that can be used to identify an individual. Thus, it can either be data that has no personal information to begin with (such as artwork files); or it is data that had personal data that was subsequently anonymised (such as by irreversibly removing all personal data). Art Works Studio Ltd collects personal data in the following circumstances:

- i. Like most websites, we gather statistical and other analytical information collected on an aggregate basis of all visitors to our website. This Non-Personal Data comprises information that cannot be used to identify or contact you, such as demographic information regarding, for example, user IP addresses where they have been clipped or anonymised, browser types and other anonymous statistical data involving the use of our website.
- ii. Clients availing of design services from Sheena K Fortune / Me and The Moon, will need their files served on a cloud server to ensure that no data is lost during the design process. Files are automatically backed up each day on a secure cloud setting, password protected and only accessible by the service provider. Clients may request access to the files and this is treated case by case for security reasons.
- iii. Once the design project has been completed, all files related to that project, that are necessary to keep for future use, are stored on a secure cloud setting, password protected and only accessible by the service provider. This is to ensure no files are lost for potential future use (i.e. future updating of artwork for digital or print use).
- iv. In cases where design clients have their own storage or server, all files will be uploaded onto that server on project completion or as part of the client review process. Clients should have their own data protection policies and, where necessary, reserve the right to request that the files relating to their projects be deleted from our storage systems.

2. Purposes for which we hold your Information

Personal Data:

We will process any Personal Data you provide to us for the following purposes:

- i. to contact you if we are to respond to any communications from you
- ii. to correspond you with regards to your booking and to process any orders from you
- iii. to contact you in cases where your child is unwell while in our care
- iv. to contact you in cases where your child has a trip, fall or incurred an injury of any sort while in our care
- v. to contact you in cases where your child has been involved in an altercation with another child and/or in cases where a case of bullying has been claimed
- vi. to review and update contact details
- vii. to notify you of changes and updates to our services and to our websites
- viii. to be used in statistical reporting regarding our web activities
- ix. to provide you with e-newsletters, to which you voluntarily subscribe and can unsubscribe from at any point
- x. for contact tracing purposes where necessary

Non-Personal Data:

We use the Non-Personal Data gathered from visitors to our websites in an aggregate form to get a better understanding of where our visitors come from and to help us better design and organise our websites. We also collect and store non-personal data to fulfill a design brief on behalf of a client.

Employees and Job candidates

If you apply to work with Art Works Studio Ltd, we will use the personal data you give us during the recruitment process and will retain it for one year after your recruitment process ends unless otherwise obliged by law to retain it. We will only share it with potential recruitment agencies and contractors if they are party to the process and to check references with third-parties nominated by you. We may keep de-personalised recruitment statistics for our own internal purposes but none of this data will identify you.

Events

When you attend a Me and The Moon event, we will need your name, email address, payment information and, in some cases, any special requirements or allergies your child may have. This information is necessary and used by us in organising and administering the event safely.

3. Disclosure of information to third parties

We will not disclose your Personal Data to third parties unless you have consented to our doing so. We will, however, disclose your Personal Data if we believe in good faith that we are required to disclose it in order to comply with any applicable law, a summons, a search warrant, a court, workplace relations forum, regulatory order, or other statutory requirement.

4. Security

Your Personal Data is held on secure servers in accordance with our data retention schedule. The nature of the Internet is such that we cannot guarantee or warrant the security of any information you transmit to us via the Internet. No data transmission over the Internet can be guaranteed to be 100% secure. Any transmission of data is therefore at your own risk. Once we receive your data, we use appropriate technical and physical security measures, including firewalls and anti-virus protection to protect your personal data, from accidental or unlawful destruction, loss, alteration, unauthorised disclosure of, or access to. Our suppliers are also required to use appropriate data protection compliance measures. We will continue to revise policies and implement additional security features as new technologies become available.

Credit card details processed online are via a secure on-line payment systems, namely Stripe and Paypal, and Art Works Studio Ltd does not have access to this information. Credit card payments by via telephone will only be retained until payment for the event has been successfully completed.

5. Retention

- i. If you unsubscribe from our communications, we will delete your contact details promptly.
- ii. Personal data will be stored for as long as is necessary for the purposes of a child attending one of our workshops, camps, events, etc. After which time, the data is deleted.
- iii. Non personal data, such as artwork, will be stored on a secure cloud setting for future use, unless requested by client to be deleted.

6. Newsletters

You can subscribe to our newsletter on our website by completing the online subscription form. When you complete the form, we record and save the content you input. We use this data to:

- i. send you newsletters; and
- ii. analyse the number of subscribers, the types of consumers that are interested in our publications, and their location (by county and country).

If you want to stop receiving our newsletter, you may do so at any time by using the 'Unsubscribe' hyperlink in every newsletter footer. Your email address may be retained to ensure you no longer receive communications from which you have unsubscribed.

7. Cookies

Our website uses cookies to distinguish you from other users of our website. This helps us to provide you with a good experience when you browse our website and also helps us to improve our site.

8. Your rights

You generally have the following rights: The right to;

- i. be informed about processing of your data
- ii. access your personal data
- iii. object to personal data processing
- iv. object to any direct marketing either use the 'unsubscribe' button on our newsletter footer or contact us directly by email to Sheena at sheena@meandthemoon.ie.
- v. personal data portability if and when it arises
- vi. have your data rectified if its inaccurate
- vii. erasure (in some circumstances)
- viii. have your data restricted or blocked from processing where appropriate

To exercise any of these rights, please email us at sheena@meandthemoon.ie. If you are not happy with the way we have handled your data, and are unable to resolve the issue with us personally, you can complain to the Data Protection Commissioner.

9. Changes to the privacy statement

If at any time we decide to use Personal Data in a manner significantly different from that stated in this statement, or otherwise disclosed to you at the time it was collected, we will notify you by e-mail, and you will have a choice as to whether or not we use your information in the new manner.
